During 2021, Thaakat Foundation: Provided an education to over 1,200 children from underpriveleged backgrounds, this includes enrichment activities such as STEM, computer literacy, montessori style learning and coding; Expanded school facilities to include 4 primary/ secondary schools, one college and one women's skills training center; Delivered 650 healthy babies at our maternal health clinics in Sierra Leone to date with 75 delivered in 2021 alone; Treated 4,000 patients across our health facilities in West Africa and South Asia, performing nearly a hundred life saving surgeries; Invested more than \$40,000 in food relief alone, providing for nutritious lunches for our students on campus as well as providing for community farm and subsidized food programs for these vulnerable and underprivileged communities; Launched over 18 solar powered water plants in drought impacted regions.
