During 2022, Thaakat Foundation:Completed our 3rd healthcare facility in Sierra Leone allowing us to treat over 30,000 patients to date, 2000+ which were treated for Malaria this year alone; Expanded DREAMS Pakistan Schools with 10 additional classrooms and adoption of a new school; Provided more than 180,000 meals through our on campus lunch program in Pakistan; Launched our first ever school in Sierra Leone with one more under construction; Invested nearly \$80,000 in sustainable programs: solar energy, subsidized food programs, local farming programs and campus improvement initiatives; Invested \$100,000 in disaster relief initiatives to support Pakistan flood victims (rebuilding 50 homes, food aid relief for thousands, medical camps); Constructed 30 solar powered water wells since 2020; Advanced medical facilities in Pakistan through addition of ENT diagnostic equipment, ultrasound machines and construction of a High Dependency Care Unit. This has allowed staff to provide hundreds of free outpatient surgeries this year; Equipped campuses with playgrounds, sports fields, computer labs and libraries to support ongoing educational and social enrichment for our students
